The New York State Annual Report is open. Gina will begin work on sections 1 - 10 on Monday. The Treasurer completes sections 11 and ff.

Three of our **Trustees** need their reappointment documented in the minutes. Belinda Feris, Sue Fink and Bob Fucci's three year terms expired in December 2019.

Gina sent out 97 thank you letters on Tuesday using a mail merge to address each one and include the amount for tax purposes.

One of our oldest computers died. February is the next scheduled time for a group order going in. We have one new monitor ready to be installed, so the cost for a **new computer** should be in the \$600's rather than the 900's. I'm not quite sure why they blessed us with that but they left it when they installed our last new machine in 2018. Kim, the new director at COB may have a line on some newer monitors available for free.

The **computer in the teen area** is running Windows 7 and too old to be serviced by MVLS to upgrade it to Windows 10. Since Microsoft has abandoned updating 7, it represents a security risk to the MVLS system. (More about this later.)

We closed out the final report on the **fire alarm system** grant by uploading photos of the installation, and the internal alarms have not been a problem lately, but the full alarm went off yesterday and the responders were not happy at having to come out. (Maybe more from Jeanne on this.)

We received a gutter repair estimate for \$285 for two twelve foot gutters and a downspout and removal of old **gutters** with the notation that they were already booking spring dates. They requested we submit the top copy of the estimate to get on their calendar. Jeanne reported that Bob thought the estimate was high. It was determined to ask if Mark Hall could fix them. Jeanne and I decided to get on the professional's calendar while exploring other options.

JoAnn, Alivia and I have all completed the sexual harassment training and signed the form.

Run by Dogs did a great program in the bitter cold on Saturday 1/18/2020. The \$200 we paid them was the dregs of last year's Stewart's grant. This year's Stewart's grant is due by 1/31/2020. The funds must be used for something related to youth. We could request youth programming again (\$800 last year and it would be nice to bring the dogs back and have our favorite musician visit) or we could consider something else. Suggestions?

At a previous board meeting, we said we would refurbish the **teen/lounge area**. Teens have been coming in after school/before games and we have been offering popcorn or snacks. They have been relatively well behaved although I did catch one vaping the other day. They seem to use it rs a lounge, so I don't think our plans in that direction are inconsistent with their needs. Gina has

volunteered to help paint that area and I am willing to do that with her. I would like to suggest we try to get rid of the big screen TV. We no longer have a movie license. No one is playing with the PS 3. We don't have any games for the PS 2. They don't use the computer, so I'm wondering whether we need one there. It is a good spot for wifi, but it is out of our sight when someone searches.

I attended a full day session on supporting community members to complete this year's digital census. The actual census day is April 1, but it will be open March 12 - 20. Reminder letters will go out March 16 to 24. Non-responders by then will get a reminder postcard April 3. April 8 to 16th are the dates for reminder letters and paper copies going to non-responders. April 20 to 27 are the dates of final reminders before you get a personal visit. The census can be completed online, by interactive voice response (IVR) or finally on paper. 2010 only had a 70% response rate. The number of Congressional Representatives and the distribution o \$675 billion in Federal funds are at stake. I will start promotional educational bits in our publicity about how we can help.

JoAnn will be attending a full day session on Summer Reading Program next week. We have started discussions with Jeanne about how it might look. This might be part of the Stewarts grant.

The MVLS Dream and Do grant awarded us \$500 for adult programming. So far we have only spent \$100 for Cindy Howell's jewelry making program which was sold out and very well received. Other programs are being planned and we may also bring Cindy back.
